**DIRECTIONS: THE LOCATION IS NEAR THE INTERSECTION OF EAST GUDE DRIVE AND NORBECK ROAD (RT. 28).**

- \* IF YOU ARE COMING TOWARDS ROCKVILLE ON RT. 28 SOUTH (NORBECK ROAD), TURN RIGHT ONTO EAST GUDE DRIVE, THEN RIGHT ONTO TAFT COURT.**
- \* IF YOU ARE COMING TOWARDS ROCKVILLE ON VIERS MILL ROAD FROM THE WHEATON AREA, TURN RIGHT ONTO NORBECK ROAD (RT. 28), THEN LEFT ONTO EAST GUDE DRIVE, AND RIGHT ONTO TAFT COURT.**
- \* IF YOU ARE COMING FROM I-270, TAKE THE EXIT FOR ROUTE 28 NORTH (DARNESTOWN/POOLESVILLE), TURN RIGHT ON RESEARCH BLVD., TURN RIGHT ON GUDE DRIVE, CROSS OVER ROUTE 355 AND AFTER SEVERAL LIGHTS (ABOUT 2 MILES), TURN LEFT ONTO TAFT COURT, JUST BEFORE YOU REACH NORBECK RD/RT. 28.**

**PARKING: THERE IS PARKING ON ALL SIDES OF THE BUILDING. STREET PARKING IS ALSO OPEN ALONG ALMOST ALL OF TAFT COURT. THERE IS ADDITIONAL PARKING ALONG THE BACK FENCE BEHIND THE BUILDING.**

**ENTRANCE: YOU CAN ENTER EITHER THROUGH THE FRONT DOOR, OR THROUGH THE CONFERENCE CENTER DOORS ON THE FAR (EAST) SIDE OF THE BUILDING UNDER THE AWNING.**
